

istration shall be in lieu of registration and license required by KRS 186.020 to 186.270.

- (4) Upon payment of a fee of fifty dollars (\$50) and an application in accordance with regulations issued by the Transportation Cabinet, the secretary of the Transportation Cabinet shall issue a certificate of registration and two (2) special license plates of a different color and design than the regular license plate, which, in the judgment of the secretary of the Transportation Cabinet, will best advertise, popularize, and promote the Commonwealth of Kentucky. These plates, besides the word "Kentucky" shall have the words, "Historic Motor Vehicle" inscribed in a conspicuous manner and carry no year date. These plates shall have a serial number beginning with, the number "LOO" and continue in a consecutive numerical sequence.
- (5) Historic vehicles may display an authentic Kentucky license plate, twenty-five (25) years or older, or a reproduction of such a plate, if the historic motor vehicle plates and the registration receipt are kept in the vehicle at all times.
- (6) The registration license and license plates of historic motor vehicles shall be valid without renewal as long as the vehicle is in existence. If the historic motor vehicle is sold, the registration and license shall be assigned and transferred to the new owner on the records of the Transportation Cabinet upon receipt of an application in accordance with regulations issued by the cabinet and payment of a fee of three dollars (\$3).
- (7) The secretary of the cabinet may promulgate administrative regulations he deems necessary to further the purpose of this section. (Enact. Acts 1968, ch. 14, §§ 1 to 5, 7; 1974, ch. 74, Art. Opinions of Attorney General. The license plate for a historic vehicle must remain with the particular vehicle which is registered with the county clerk, and for which the plate was purchased and cannot be transferred or changed to other historic vehicles that may be in the owner's possession. OAG 65-540.

When a historic vehicle is sold and transferred in Kentucky to someone outside the state, the plate or tag must remain with the vehicle, OAG 69-540.

#### 186.044. License plates for recipients of a Purple Heart medal.

- (1) Upon application to the county clerk of the county of his residence, a recipient of a Purple Heart medal shall be issued one (1) five (5) year license plate upon the payment of a twenty-five dollar (\$25) license fee and a three dollar (\$3) clerk's fee.
- (2) The application shall be accompanied by written proof from the appropriate branch of the

United States Armed Forces stating that the applicant is a recipient of a Purple Heart medal. Annually thereafter, upon application and after payment of an eleven dollar and fifty cent (\$11.50) state fee and a three dollar (\$3) clerk's fee the clerk shall issue a decal to renew the vehicle registration. The decal shall be affixed to the five (5) year registration plate.

- (3) The plate shall bear the name "Purple Heart," a registration number and an appropriate logo to be determined by the Transportation Cabinet. The applicant may purchase only one (1) such registration plate annually, and it shall be for a vehicle in which he has total or partial ownership.
- (4) Upon sale or transfer of a vehicle bearing a special plate, the owner shall remove the plate and return, it, along with certificate of title and registration to the county clerk. When the special plate is presented to the clerk, he shall reissue it, for a three dollar (\$3) clerk's fee for use on any other vehicle owned by the same person purchasing the Purple Heart plate for the current period. The license plate and decal on the other vehicle shall be turned in to the county clerk, who shall forward the plate to Frankfort.
- (5) If the inscriptions on the Purple Heart plate become indiscernible within five (5) years from the date of issue, the owner may obtain a replacement plate free of charge.
- (6) Purple Heart registration under this section shall expire on December 31 each year.
- (7) The secretary of the Transportation Cabinet shall promulgate administrative regulations and prescribe necessary forms to further the purpose of this section. (Enact. Acts 1988, ch. 178, § 1, effective July 15, 1988; 1994, ch. 428, § 8, effective July 15, 1994.)

186.045. Entry of assignment of perfected security interest into system — Termination statement — Filing — Time — Fees — Notations showing security interest.

CD Whenever a perfected security interest is assigned, the assignor shall immediately give a statement of assignment to the assignee and at the same time deliver another copy of the statement to the debtor. The assignee shall, within thirty (30) days thereafter, present a copy of the statement of assignment to the county clerk in whose office the security interest was noted on the certificate of title. Upon receipt of the assignment, the county clerk shall mark the same as provided in subsection (2) of KRS 355.9-405 and attach it to the title lien statement. The county clerk shall enter the assignment of the perfected security interest into the automated vehicle information system. For this service the county clerk shall collect a fee pursuant to KRS 64.012.
